These complimentary fair housing trainings are being held to celebrate National Fair Housing Month and are open to the public; however, pre-registration is required.

#### Applying Fair Housing in Your Daily Life – Wednesday, April 19

This event will be held from 6-8 p.m. in Meeting Room A of the lowa City Public Library, 123 S. Linn Street, and will focus on recognizing and reporting housing discrimination in rental, sales or insurance. Some topics are: Stopping Racial, Religious and Sexual Harassment in Housing; and Many Ways to Promote Neighborhood Diversity.

# *Promoting Fair Housing in your Business and Complying with the Law* – Thursday, April 20

This event will be held from 8:30-10:30 a.m. in the Conference Board Room at the Johnson County Extension Office, 3109 Old Hwy. 218 South. Training will cover the latest housing discrimination issues being raised in the rental and sales markets. Several Quick Quizzes are part of the training to help you evaluate your understanding of the Fair Housing Act. And there will be plenty of time for questions and answers.

**Some of the topics include:** Is advertising via social media increasing access to housing?; What is linguistic and email profiling and can I avoid it?; Is my apartment building accessible?; Can I suggest to an Asian American buyer to work with the Asian American agent?; Does the parking lot have legal size handicapped spaces?; How does a real estate professional address racial, religious or sexual harassment in rental complexes or neighborhoods?; Can I promote neighborhood diversity without violating the law?

# City of Iowa City Begins Curbside Compost Program

The City of Iowa City began collecting curbside compost on Monday, March 13, 2017.

The new program will help divert some of the roughly 18,000 tons of food waste that reaches the lowa City

Landfill each year. Residents will be able to compost many different

types of foods, including fruits/vegetables, meats and grains, as well as paper products like pizza boxes, leftover containers and uncoated, disposable dishes.

Food waste will be collected curbside in the same containers and in the same trucks used for yard waste, and will be taken to the Iowa City Landfill's Commercial Compost Facility.

#### HOW TO PARTICIPATE

Curbside composting is available to residents who currently receive City of Iowa City garbage, recycling and yard waste services. Residents must have an annual yard waste sticker and supply their own 35-gallon container that includes a lid. Set your container out by 7 a.m. on your regular trash, recycling and yard waste collection day.

### YARD WASTE STICKERS

The current orange yard waste stickers will be accepted until March 31, 2017. New, purple yard waste stickers can be purchased for \$12.50 and will be valid now through Dec. 29, 2017. Stickers can be purchased in-person at City Hall, by mail or by phone from 8 a.m. to 5 p.m., Monday through Friday.

In-person: Visit City Hall at 410. E. Washington Street By phone: Call 319-356-5066 to pay by Visa or MasterCard By mail: Mail orders to Cashier at City Hall and include the name, service address, mailing address and a \$13 check to cover the postage and a handling fee for each sticker.

For information on how to compost, a full list of items that are safe/unsafe to compost, and other waste reduction tips visit <u>icgov.org/foodwaste</u>. It is important to reduce food waste first, and then compost.
